During Wacky Week, the Grade 3 children will attend a one-night camp at the Back 2 Basics campsite, situated on a Pine plantation 8 km outside of the beautiful town of Grabouw. The site is on the buffer zone of the unique Kogelberg Biosphere and on the foot of the Groenberg Mountains.

The emphasis of this camp is responsibility, team work and independence. Experienced Facilitators from Innovative Adventures will run the activities, which will include swimming, participating in a night hike, conquering the obstacle course, experiencing the exhilaration of the zip line and water swing as well as the low and high ropes course to name a few.
